



Registration Terms and Conditions

1. Completed registrations will be acknowledged within 7 working days.
2. Full payment for registration fees is required within 10 working days of invoice.
3. All payments must be made to AORTIC 2019.
 - 3.1. Registration payments must be made in United States Dollars (USD).
 - 3.2. Any short payment resulting from bank charges and/or exchange rate fluctuations will be charged back to the registrant.
4. Cancellations must be received in writing by the AORTIC 2019 Conference Organiser.
5. Cancellation fees will be imposed as follows:
 - 5.1. Registrants that cancel 90 days prior to the start of the AORTIC 2019 Conference (7 August 2019) will receive a full refund minus a 10% administration fee.
 - 5.2. Registrants that cancel between 89 and 30 days prior to the start of the AORTIC 2019 Conference (8 August to 6 October 2019) will be refunded 50% of the amount paid; if fees are outstanding the registrant will be liable for 50% of the amount due.
 - 5.3. No refunds will be provided for no-shows or registrants that cancel within 30 days of the start of the AORTIC 2019 Conference (after 6 October 2019), and the registrant will be liable for the full amount due.
 - 5.4. No refunds will be provided in respect of membership fees; the refund policy above relates to conference participation fees only
6. Registrations are transferable only if the AORTIC 2019 Conference Organiser is informed in writing.
7. Registrations may not be shared, i.e. shared name tags will not be issued, and name tags may not be shared.
